League Fees: \$1300 per season (\$1200 if paid in full by the day of first game). A \$300 deposit is due at time of registration for new teams. The \$300 deposit will be subtracted from the team's LAST scheduled payment of the season. Full league fees are due and no refunds will be issued to players and/or teams that withdraw after schedules are published.

Payment Schedule for teams not making full payment by the day of their first game: 25% (\$325) due prior to the first game, 50% (\$650) due prior to the third game, 75% (\$975) due prior to the fifth game and 100% (\$1300) due prior to the seventh game. Teams behind in payments will forfeit each game until payments are current. \$25.00 fee will be charged on all returned checks.

Rosters & Proof of Age & Sign-in: A preliminary roster, with a maximum of 15 players, must be turned in by the registration deadline. Additions may be made until the sixth game. Rosters are frozen from the sixth game through the playoffs. Players must play in at least five (5) games to be eligible for playoffs. Any player, not having played in a game at the time rosters are frozen, will be removed from the team roster. Teams will forfeit all games in which non-rostered players participate. Proof of age must be provided upon request. Each rostered player must complete a waiver form prior to playing or practicing. **All players are required to sign-in at the rink office prior to each game.**

Rules: All games are played using the Official Rules of USA Hockey Inline with additional house rules. It is each player's/captain's responsibility to know the rules. It is not the referee's responsibility to explain the rules. Rulebooks are available at the rink and are posted on the website.

Scheduling: Teams are scheduled on a space available basis, in the order in which they are registered. New teams will not be placed on the schedule until their deposit has been received. Teams must provide their own jerseys.

Practices: One full-rink, one hour practice is included, on a space available basis. Practice must be used prior to the end of the regular season.

Rivertown Sports reserves the right to determine an individual player's skill level rating to be used to ensure competitiveness within the divisions. We also reserve the right to remove any player from a team, or team from a league, whose skill level is substantially above that of the league the team is playing in. New teams or teams making changes to their roster should check with management for guidance on skill level placement for their team. I understand that I am responsible for full/on-time payment of my team's league fees and turning in all individual player waiver forms. I also understand that there will be penalties, as stated above, if my team's league fees are not paid on time. In addition, I understand that I may be held financially liable for damage to the facility done by members of my team including, but not limited to, broken floor tiles, locker room damage, etc.

I acknowledge that I am entering into a contract that requires payment as stated above.
